



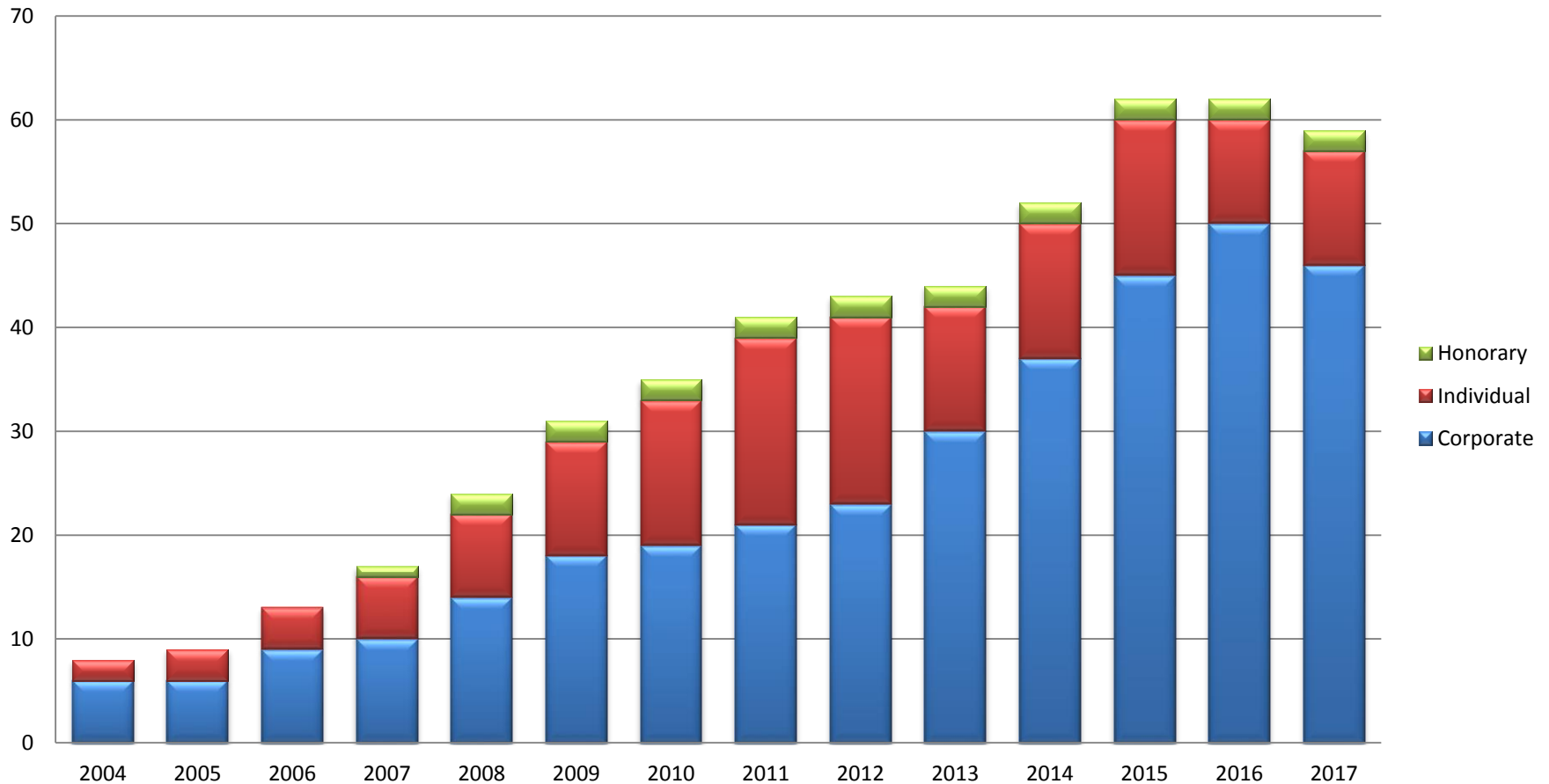

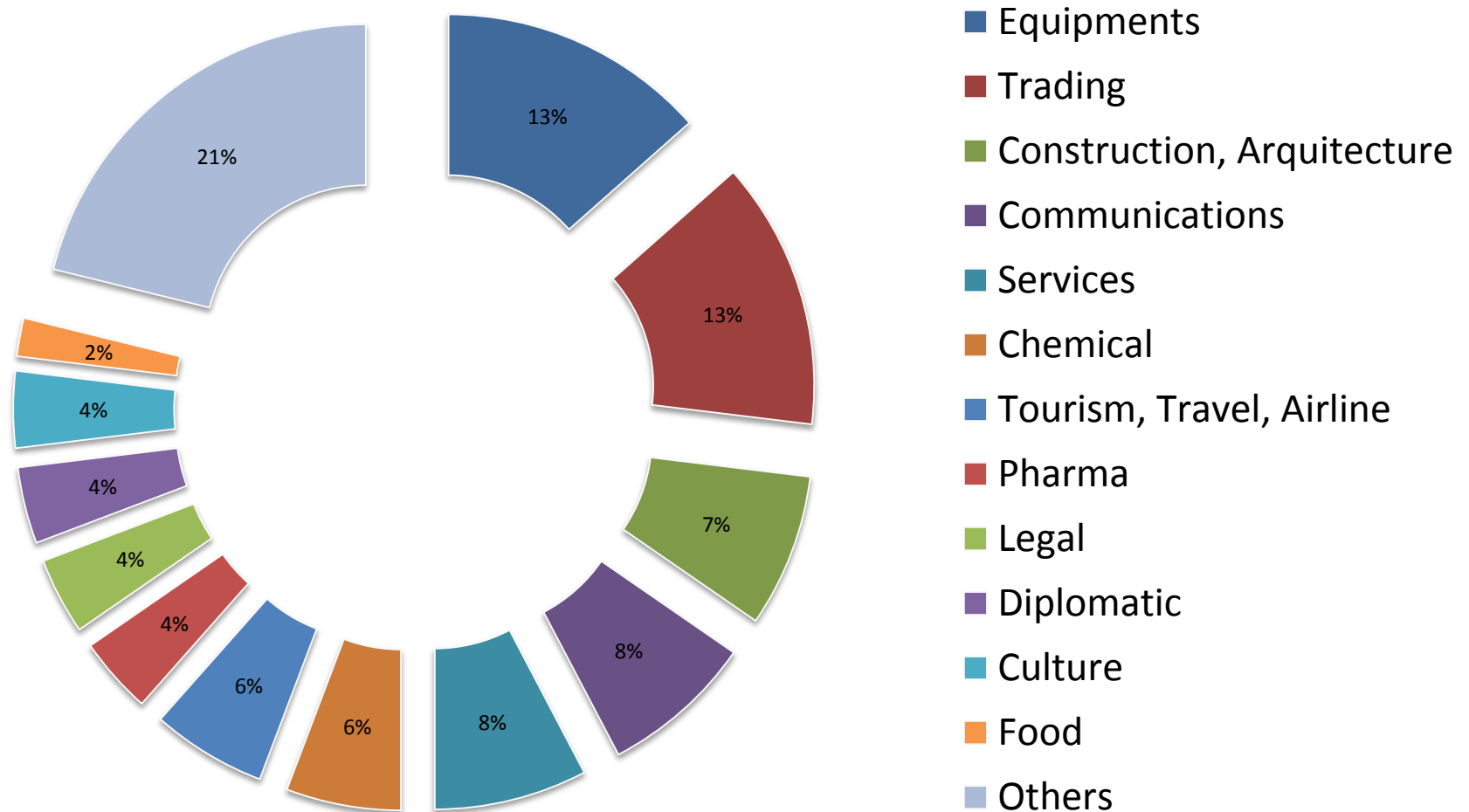

SCC / CSBC can:

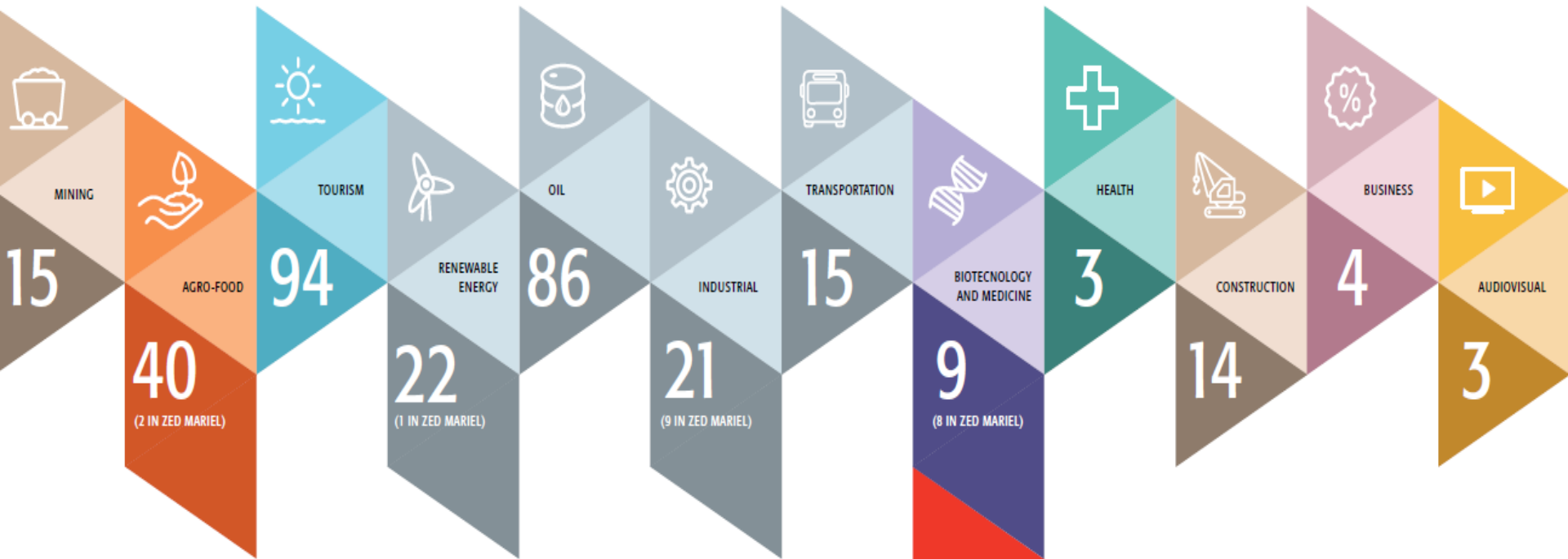
- ✓ give objective one-time assessment
- ✓ invite to min. 2 annual meetings (CU / CH)
- ✓ be used as network platform
- ✓ include individual queries and follow-up in annual action list CSBC
- ✓ propose specialists + matchmaking according to Cuban regulations

SCC / CSBC cannot:

- x issue legal opinions
- x substitute work of Consulates (regulatory; migration, customs, etc.)
- x offer and invoice consultancy services

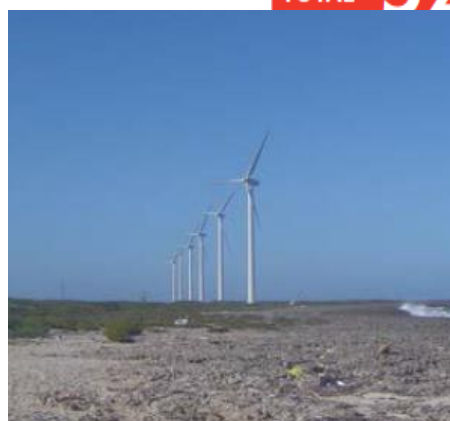
Cuba-Switzerland Business Committee (CSBC)

- Signed in 2013 between Cuban Chamber of Commerce and Switzerland Global Enterprise. Promotes, on a non profit basis, the economic and trade relations between Cuba and Switzerland.
- Organized in a Cuban section and a Swiss section, each responding to legislation of respective country. SwissCubanCham acts as Swiss section.
- SCC members can populate annual CSBC Activity list which is checked monthly between the permanent Secretaries of both sections.
- **MANDATORY:**
 - SCC General Terms and Conditions
 - **More than specific and “one time” related advise / consultancy must be contracted by interested parties through Cuban consultancy firms, according to Cuban regulations.**
