To meet the expectations of international trade partners, we have launched the [co.kig.pl](https://co.kig.pl) online platform. This platform enables exporters to electronically submit applications and receive digital certificates, while importers can instantly verify their authenticity online. Appreciating the key importance of your Chamber of Commerce in supporting entrepreneurs operating in the international markets, **we would be very grateful for providing an information on the availability of Polish digital certificates of origin to the appropriate offices and institutions** involving in trade exchange in your country.

#### **Benefits of digital Polish Certificates of Origin:**

##### **Security:**

- Each Certificate is secured with an electronic certificate of the Polish Chamber of Commerce
- Authenticity verification is available online at [co.kig.pl/verify](https://co.kig.pl/verify)
- Certificates will also be available for verification in the global database maintained by the International Chamber of Commerce (ICC)
- The system complies with the highest digital security standards confirmed by an independent audit

##### **Convenience:**

- We accelerate economic efficiency – electronic documents can be sent instantly worldwide
- All procedures are carried out electronically via the Internet
- Reduced waiting time from application submission to certificate issuance
- Minimized paper document circulation

Should a foreign party require a physical certificate, exporters can conveniently obtain a paper version as well.
